## Summit Artspace Gallery

**Eligibility:** Presented by the Alliance for the Visual Arts (AVA), this show is open to all current members (dues paid by October 15) of the society organizations of AVA: Akron Society of Artists, Artists of Rubber City, Cuyahoga Valley Art Center and Women's Art League.

**Medium:** Open to all artistic media.

**Entry Fee:** \$30 for one or two pieces. Entry fee is non-refundable. Checks payable to AVA

**Drop off work** on TUESDAY, November 21, from noon until 7p.m.

**Jurors: Due to unforeseen circumstances, the jurors will be announced at a later date.**

Use the space at the bottom for your labels.

**Prizes:** Prizes will be awarded at the discretion of the jurors. Juror's Awards announced at 6:30 p.m. Friday, December 1<sup>st</sup>. The People's Choice Award of a hand-crafted Kaleidoscope, by artist Bob Pozarski will be announced December 31<sup>st</sup> at 8 p.m. during First Night Celebration.

**Open Reception:** Friday, December 1, 5 to 8 p.m.

### Entry Procedures:

- The show will be juried from the original artwork.
- Artwork is to be hand delivered to the Summit Artspace Gallery on Tuesday, Nov. 21, noon – 7 p.m.
- All art work must be identified on the back with artist's name, title, medium and price. **Labels provided below.**
- Two-dimensional work must be securely wired for hanging; saw toothed hangers are NOT permitted.
- Artwork must be original and begun since Nov. 2015.
- Artists' entries must have never before been exhibited in the SA Gallery.
- All artwork must be completed solely by the artist. No collaborative, student or workshop work.
- Size of artwork – No size limitations. Weight limit of 50#. Triptychs or diptychs are considered 1 piece.
- The committee has the sole discretion concerning the artist's compliance with these rules.
- Artwork need not be for sale.
- **PLEASE NOTE; IF YOU ARE JURIED INTO THE KALEIDOSCOPE EXHIBITION YOU MUST GALLERY SIT AT LEAST ONE SHIFT OR FIND A RESPONSIBLE ADULT TO TAKE YOUR PLACE.** Bring your calendars with you when you drop off so you can plan when you will gallery sit.

### Return of Artwork:

Artists will be notified by phone OR e-mail by Saturday, November 25.

Artwork not juried in the show should be picked up on Monday, November 27, between 10-1 p.m. and 4-7 p.m.

Artwork in the exhibition should be picked up on Monday, January 8, 2018, 9am -1pm; 4-7 pm **New Time!**
