DESCRIPTION:

Entries may be submitted into the following categories: Watercolor Media, Water Based Media, Oil Based Media, Dry Media, Mixed Media, 3-Dimensional Media & Photography. Please view the back of this prospectus for category descriptions. **CVAC reserves the right to determine acceptability of any entry.** The juror TBA shall select which images are to be displayed in the exhibit and a Best of Category winner and up to 2 honorable mentions for each category. A people's choice selection process shall dictate a People's Choice Category winner for each category, to be announced on August 13th. Best of Category winners will receive a cash prize of \$100. People's Choice winners shall receive a \$50 Cheap Joes gift card.

ELIGIBILITY:

Must be a current member of the Cuyahoga Valley Art Center. Membership sign-ups and renewals are allowed during take-in for submissions.

LIABILITY:

Entries will be handled with all possible care, but the Cuyahoga Valley Art Center will not be responsible for loss or damage to submitted artwork from any cause whatsoever. Submission of artwork to this exhibition implies acceptance by the artist of all conditions set forth

in this prospectus. CVAC is not responsible for abandoned artwork.

RULES:

All entries must be ready for hanging. All 2-D hanging work must be framed, with screw eyes and wire (no saw tooth hangers). Work must be under glass or Plexiglas if on paper. **Maximum size must not exceed: 38" X 38" FRAMED in either direction.** No work may exceed the weight of 100 pounds and it must be able to fit through a standard door. **All wrapped canvas submissions must be finished with painted edges.** All works shall be labeled with the artist's name, address, email address, phone number, title and price. If an image is not for sale, please label it as such. For all exhibitions here at CVAC, all individually framed (or unframed) artworks are considered to be ONE SUBMISSION. CVAC no longer accept diptychs, triptychs or multi-series artworks as one individual entry unless they are submitted as one framed piece and meet ALL of the requirements listed within the prospectus. **This is a juried entry exhibition,** meaning that a juried selection shall take place, dictating which images will hang in the show. If an entry is not selected, the artist will be contacted by **Monday, July 26th** to pick-up their artwork. Refunds are not issued for works not accepted into this exhibition. **Cuyahoga Valley Art Center reserves the right to determine the acceptability of any work.** Items not conforming to this prospectus will be automatically rejected. Cuyahoga Valley Art Center is not responsible for, nor able to store, abandoned artwork. Unsold works *must be* picked up **on either August 27th or 28th.**

SALES:

A commission of 30% will be charged on all sales. Payments will be distributed to artists after the conclusion of the exhibition in a timely fashion. Purchases by private and corporate collectors will be strongly encouraged.

PUBLICITY:

The Cuyahoga Valley Art Center reserves the right to photograph participating artists and exhibited works for marketing purposes.

CATEGORY DESCRIPTION

WATERCOLOR MEDIA:	This category will include any media for which water, not oil nor polymers, are used as the binding agent, with the resulting artwork considered to be a watercolor. Mediums such as; watercolor paints, watercolor pencils, watercolor markers, and watercolor pastels are all included within this category, even if utilized together in one image. Acrylic and Tempera paints are not applicable within this category.
WATER BASED MEDIA:	This category will include any media that is water-based such as acrylic paints, and tempera paints.
OIL BASED MEDIA:	This category will include any media that uses oil as its binder such as oil paints, oil pastels, oil based markers, etc.
DRY MEDIA:	This category will include media that is dry such as graphite, charcoal, pastels, colored pencils, Conté crayon, silver point, etc. and media the uses a fluid solvent or carrier such as marker, pen or ink (alcohol ink).
MIXED MEDIA:	This category will include any work that combines traditionally distinct visual art medias such as work that might include both paint, ink and collage.
3-DIMENSIONAL MEDIA:	This category will include any work that occupies space through the dimensions of height, width and depth.
PHOTOGRAPHIC MEDIA:	This category will include any lens-based media, including but not limited to images made by film, scanner, screen-capture, digital camera, and any means of mobile photography. CVAC invites photographers working in all mediums, styles and schools of thought to participate. Experimental and mixed techniques are welcome. Only 2-D work is eligible for this category.

**The final decision regarding category placement shall be left up to the juror.*
