WPA RULES:

Paintings must be framed and ready for hanging with screw eyes and wire. NO SAWTOOTH HANGERS. We suggest that the same look of frame be used for all pieces. The image area dimensions must NOT EXCEED 4"x 5" or 3 1/2"x5 1/2". The framed art, including the matting, must be per official WPA rules of a maximum of 8"x10" or 9"x10". Please affix a WPA label on the back and be sure your name, address, the title of the painting, and the prices are legible. The minimum selling price is \$75.

SHIPPING:

Shipment should be made in REUSABLE cartons. All entries will be returned in the same cartons in which they were received. Entries must meet post office and UPS regulations and unless otherwise specified, cartons will be returned to UPS. CVAC recommends

the use of Plexiglass for shipped pieces. Please include an entry form, a check payable to CVAC to cover entry fees, and a pre-paid return label for shipping (if the art is shipped).

ENTRY FEE:

\$25 for up to eight (8) paintings. Shipped entries must include a pre-paid return shipping label. (\$3 of the entry fee goes towards the Whiskey Painters of America). Please make check payable to: CUYAHOGA VALLEY ART CENTER or CVAC

LIABILITY:

Artists must provide their own shipping insurance. Entries will be handled with all possible care, but the Cuyahoga Valley Art Center will not be responsible for loss or damage to submitted artwork from any cause whatsoever. Submission of artwork to this exhibition implies acceptance by the artist of all conditions set forth in this prospectus.

SALES:

All entries must be for sale. A commission of 30% will be charged on all sales. Payments will be distributed to artists after the conclusion of the exhibition in a timely fashion. Purchases by private and corporate collectors will be strongly encouraged.
